Member dues payments to the Metro Centre Association of REALTORS® are not deductible as charitable contributions. A portion of the dues may be deductible as an ordinary and necessary business expense. Dues less 17.08% or \$23.00 of the New Jersey REALTORS® dues, as well as 38% or \$57.00 of the NAR dues may not be deducted from the member's income tax due to lobbying efforts. Compliance with the Tax Reform Act of 1993 requires that the portion of dues attributable to lobbying and political activities at the State and Federal levels of government be considered nondeductible for income tax purposes. Local dues do not fall under this tax code. The \$35.00 NAR Consumer Advertising Campaign (CAC) qualifies as fully deductible. Dues breakdown as of 1/1/21: MCAR \$155, New Jersey REALTORS® \$140 and NAR \$185.00 - includes the \$5 New Jersey REALTORS® legal assessment and \$35 NAR CAC assessment.
